LINGNAN UNIVERSITY

A Summary of Discussions and Decisions of the Council Meeting Held on 17 October 2022

- 1. The Council WELCOMED Mr LAW Lam Wai Barry and Mr MOK Man Too Michael who attend the Council meeting for the first time.
- 2. The Council RECORDED a vote of thanks to the outgoing lay members, Dr FOK Wing Huen, Mr HO Lik Chi Nicholas and Mrs Emily LAM HO whose terms of office would be completed on 22 October 2022.
- 3. The Council RECEIVED a report from the President on the activities of the University, including:
 - (a) The University has recently established new agreements on academic cooperation with the following institutions:
 - Essex Business School, University of Essex (the UK)
 - Instituto Politécnico Nacional (Mexico)
 - School of Law, University of Essex (the UK)
 - Università Commerciale Luigi Bocconi (Italy)
 - University of Science and Technology Meghalaya (India)
 - University of Strathclyde (the UK)
 - (b) The University has renewed its inter-institutional agreement of cooperation with the following institutions:
 - Aberystwyth University (the UK)
 - Calvin University (the USA)
 - FH Kufstein Tirol University of Applied Sciences (Austria)
 - Saint-Petersburg State University of Economics (Russia)
 - Seoul National University (Korea)
 - Shanghai Lixin University of Accounting and Finance (China)
 - University of Bucharest (Romania)
 - (c) In the 2022-23 funding exercise, the University has 37 projects funded by the General Research Fund (GRF), Early Career Scheme (ECS), and Humanities and Social Sciences Prestigious Fellowship Scheme (HSSPFS) at a total sum of HK\$16 million which represents an increase of nearly 70% compared to previous year. The project, "Quantitative History of China: Historical Roots of Recent Success and Future Development" on which LU collaborates with four other UGC-funded universities has been approved for HK\$75 million under the Areas of Excellence Scheme.
 - (d) Professor XIE Haoran and Professor WONG Man Leung of the Department of Computing and Decision Sciences have been awarded the Gold Medal and International Special Award (Turkish Inventors Association) at the 7th International Invention Innovation Competition in Canada (iCAN) 2022 for their "Personalized Vocabulary Learning System based on Artificial Intelligence Techniques" in collaboration with Professor ZOU Di of The Education University of Hong Kong.
 - (e) The Research and Knowledge Transfer Excellence Awards Presentation Ceremony cum Mini-Exhibition of Knowledge Transfer/Entrepreneurship Projects was

- successfully held on 22 September 2022 and attended by more than 100 participants, including Professor WONG Yuk Shan, RGC Chairman, Professor James TANG, Secretary-General of the UGC, our Council Chairman, Council Deputy Chairman, and Council and Court members. 72 awards were presented to scholars in the categories of Research Output Excellence Award, Young Researcher Output Award, Research & Knowledge Transfer Fund Award RGC Grant, and Government-Industry-Academia Collaboration.
- (f) The LU Chinese Debate Team won the Inter-Collegiate Debate Competition on 14 August 2022. The team's third debater (LAM Yuk Sang) and second debater (Chui Wing In) received the Best Debater awards in the finals and semi-finals, respectively.
- (g) The LU Student Flag Raising Team participated in the National Flag Raising Etiquette Competition for the Youth held on 4 September 2022. The Team won the championship (Tertiary Institution Category) and in addition one of the team members also received "The Most Outstanding Flag Bearer" award.
- (h) The naming ceremony of The Chinese Manufacturers' Association of Hong Kong (CMA) Multi-functional Area (香港中華廠商聯合會多用途空間) was held on 14 October 2022 because the original named facility the CMA Integrated IT Study Centre, from 4/F, Patrick Lee Wan Keung Academic Building had to be designated for other purposes. Thus, the newly named area in the Wofoo Joseph Lee Student Activity Centre.
