#### 1. New Secretary to the Council

- (b) The meeting APPROVED the appointment of Professor Robin SNELL to the Court for a term of three years with effect from 21 June 2009.

#### 4. Appointment to the Investment Sub-Committee

The meeting APPOINTED Mr Roger YUEN Kwong-ming as a member of the Investment Sub-Committee.
