### Submitting Application for Exemption of Prerequisite for UG Courses

USER GUIDE FOR STUDENTS

#### Important Notes

- 1. Students should check the course descriptions and information of prerequisites/restriction of the courses they intend to register by referring to the Registry webpage (*Registry > Undergraduate Programmes > Course Description*). If there is a prerequisite for a course, a student must meet it before taking the course concerned. Students will be responsible for the consequences of taking such a course contravening the requirements without special approval.
- 2. Students who are approved to register the courses online through this system are required to register courses via myLingnan Portal during the stipulated Online Registration and Add/Drop periods.
- 3. Students who are approved to register the courses online through this system should note that courses offering Departments/Units reserve the right to review the approved applications during the stipulated Add/Drop period of the particular term to ensure that the students are eligible to study the courses.
